



## **RULES REGARDING THE USE OF THE “CAMPING AREAS”**

**1. SETTING UP.** Camping is allowed only within the “Camping Area” the perimeter of which is marked out by bollards and shown on maps available within each area.

**2. OPENING HOURS.** You are permitted to remain in the camping area only between 8am on the first day and midday on the last day stated in your confirmation.

**3. FIRE.** A fire may be lit solely for the purposes of preparing food. Only the following may be used:

- Purpose-built barbecues that form part of the camping area.
- Gas cylinders of up to 13kg. These must be placed on a flat surface, free from vegetation and nearby objects. They must remain within the perimeter of the camping area at all times.

**During the “High Risk of Fire” Season - ie July, August and September - IT IS EXPRESSLY FORBIDDEN TO BURN A FIRE.**

**4. WATER.** You must use water sensibly and properly at all camping areas and ensure that taps are fully turned off after use. You must not use or take water away from the camping area.

**5. WASTE.** It is forbidden to dump or tip any kind of waste. Rubbish bags must be properly sealed and placed in the containers provided.

In areas with sewage collection for caravans, you must adhere to the established rules.

**6. ANIMALS.** Pets must remain on a lead and under the owner/carer’s direct control at all times. You must comply at all times with the current Animal Protection Act and all follow-on regulations.

**7. NOISE.** The use of generators, music equipment, loudspeakers, televisions and other noise-generating device that might disturb other users is prohibited - except in exceptional cases, and with prior authorisation.

**8. MOTOR VEHICLES.** Motor vehicles must be parked in the designated parking area. You must not under any circumstance obstruct traffic from using the access roads, or access to any road/track, or emergency route. It is also prohibited to sleep overnight in the designated parking areas.

**9. BICYCLES AND HORSES.** It is forbidden to ride bicycles or horses within the perimeter of the camping area, except in exceptional, previously approved cases.

**10. FURNITURE.** You must make proper use of the facilities and furniture provided. It is forbidden to do anything that goes contrary to the use for which they are designed or which goes against their proper upkeep.

The use of small folding furniture (tables, chairs, umbrellas, deckchairs, etc) is permitted so long as it does not prevent or hinder others from using the camping area normally. You are not, however, permitted to set up other large equipment or items such as bouncy castles, tents, zip lines, swings, etc - except in special cases with the prior express permission of the Council’s Environment Department.

**11. COMPLYING WITH THESE RULES.** Failure to comply with any of these rules may lead to your authorisation being revoked and the immediate suspension of your activities, upon request of the security staff responsible for monitoring the camping areas, and regardless of the administrative authority in which your failure to comply has occurred.

Users are also liable for all and any damages that may be caused to the camping areas and to third parties, and the Gran Canaria Council shall be exempt from any liability.

Said Council may also confiscate any items left behind by users, and such users may be liable to a penalty for this.
